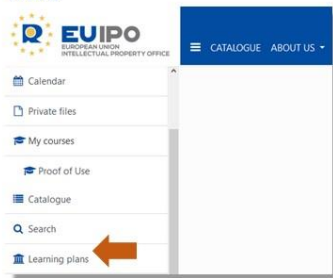

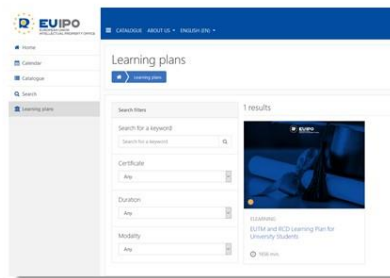


### How to download certificate of completed learning plan
